Fabricator Challenge

Official Rules and Guidelines

SPONSOR: The Sponsor of the Challenge is Taffy Event Strategies LLC in its capacity as agent for International Tile Exposition t/a Coverings ("Sponsor") 2300 Clarendon Blvd., Ste. 305, Arlington, VA 22201.

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE CHANCES OF WINNING.

ELIGIBILITY: The Challenge ("Challenge") is open only to legal residents of any one of the 50 United States or the District of Columbia who are 18 years of age or older at time of entry ("Entrant") who complete an official entry form in accordance with the Entry Procedures below during the Sweepstakes Entry Period, and (iii) meet and comply with the requirements for winning below. Employees of Sponsor, its affiliates, subsidiaries, advertising, and promotion agencies, and suppliers, (collectively the "Employees"), immediate family members and/or those living in the same household of Employees are not eligible to participate in the Challenge. The Challenge is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

In order to participate in the Challenge, an Entrant must 1) be a Coverings 2023 qualified event registrant in the tile & stone industry 2) visit 15 of the 15 participating exhibitors in the Machinery & Allied Products Pavilion and get their playing cards marked with a unique stamp from each exhibitor and 3) submit their completed card to the submissions bin at the Fabricator Stage, booth 4193, before 12:00 PM EDT on April 21, 2023. Entrants must cover their own transportation to and from the Coverings 2023 conference.

AGREEMENT TO RULES: By participating, the Coverings registrant, the Entrant, agrees to be fully unconditionally bound by these Rules, and represents and warrants that Entrant meets the eligibility requirements. Any false information provided within the context of the Challenge by any Entrant concerning identity, postal address, telephone number, or non-compliance with these rules or the like may result in the immediate elimination of the entrant from the Challenge.

ENTRY PERIOD: The Entry Period begins on April 18, 2023, at 9:00 a.m. Eastern Time (ET) and ends on April 21, 2023, at 12:00 p.m. ET. (the "Challenge Entry Period") Any entries received outside the Challenge Entry Period will be null and void.

ENTRY PROCEDURES. To enter the Challenge, Entrants must get their official playing cards marked with a unique stamp from 15 of the 15 exhibitor participants, and they must submit their completed card to the submissions bin at the Fabricator

Stage, booth 4193, before 12:00 PM EDT on April 21, 2023. Playing cards are provided at 1) registration, 2) booths of participating exhibitors and 3) the Fabricator Stage, booth 4193. All entries become the property of the Sponsor and will not be acknowledged or returned. Entrants must furnish their name and email address on the official entry form to be eligible to win. By furnishing an email address, Entrants agree to receive regular emails from Sponsor during and after the Challenge. Limit of one (1) Challenge entry per person. No photocopies, facsimiles, or other mechanical reproductions of official entries are allowed. Entrants that violate this rule may be disqualified.

CHALLENGE PRIZE:

One prize will be awarded. No other prize substitution shall be permitted. The prize is nontransferable. All prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of the Challenge winner ("Winner"). No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Winners understand that upon receipt of the prize, Winner may receive an IRS 1099 form at the end of the calendar year in which the Winner receives the prize whether the Winner decides to accept the prize or not.

ODDS: The odds of winning depend on the number of registered eligible entries received.

WINNER SELECTION AND NOTIFICATION: Winner will be selected by the Sponsor and will be based on challenge completion and overall participation. The decision of the Sponsor is final. Winner will be notified by email within ten (10) days following selection of Winner. Sponsor shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within five (5) days from the time award notification was sent, then the prize may be forfeited, and an alternate Winner selected. TERMS & CONDITIONS: Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Challenge should virus, bug, non-authorized human intervention, fraud, or other cause beyond Sponsor's control corrupt or affect the administration, security, fairness, or proper conduct of the Challenge. In such case, Sponsor may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Challenge or website or violates these Terms & Conditions. Sponsor has the right, in its sole discretion, to maintain the integrity of the Challenge, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Challenge rules; or the use of bots, macros, scripts, or other technical means for entering.
